The statement of disclosures should be completed in the following manner: Attach a copy of your worksheet ("Disclosure Worksheet"). Attach a copy of your Federal Financial Statements. All attachments should be in the format of Adobe Portable Document Format (PDF). Attach the Disclosure Worksheet and the Federal Financial Statements. The Disclosure Worksheet must be uploaded as an attachment to your statement of disclosures, and the Federal Financial Statements must be uploaded as an attachment to your statement of disclosures. Make sure to state in the Disclosures Worksheet that you have attached the Disclosure Worksheet and the Federal Financial Statements. Under the "Description of Business" section, include the following information: Describe your business, including your business address, telephone number, and fax number. Include the country and state where your business is located. In the "Business or organization" section, state your connection to this business, and the length of time that you will be involved in the business. If you are a Corporation, Partnership, Trust or Corporation, provide the names of the members. In the "Relationship to the Issuer" section, state the source of the funds used to purchase the common shares. In the "Activities of the Issuer and Persons Controlled" section, provide the amount and source of the funds used to purchase the common shares.
